**Vendor Location: Basin Spring Park, Downtown Eureka Springs  
Saturday, October 27, 2018 – Noon to 8PM**

This year will feature a **THRILLER** dance workshop with Melonlight Dance in the Basin Park from Noon to 2pm, and then the Zombie Crawl Parade begins at 6:30pm at the Eureka Springs Public Library.

All vendors will be located in Basin Spring Park. Vendors must provide their own display tables and chairs. “Pop-up” style canopies are also allowed to ensure protection of goods against unexpected inclement weather, but they must have open sides. Pop-up canopies should be located along the back wall of the park where traffic will not be impeded. We encourage vendors to decorate their space to fit the Halloween and/or Zombie theme.

**The vendor fee for a 10' x 10' outdoor space is only \$20.** Please see the application form below for details. **An approved application and paid vendor fee allows you to conduct business in your reserved space in the Basin Spring Park from Noon to 8pm on the day of the event only: Saturday, October 27, 2018.**

# **TERMS OF PARTICIPATION FOR 2018 ZOMBIE CRAWL EVENT VENDORS**

## **APPLICATION**

1. The number and types of vendors will be controlled to assure appropriateness to the event and to limit duplications. Vendors featuring Halloween, and/or zombie themed original crafts, services, and products will be given preference.
2. Vendors will be contacted upon approval via e-mail or, if no e-mail is provided, by phone call.
3. Rejected applicants will be notified prior to the event and your fee will be returned at that time.
4. Vendor application should list ALL types of items for sale/services offered. If you do not list an item on your application, we reserve the right to ask you to remove that item from your vendor booth on the day of the event.
5. Any vendor space, whether contracted and paid or not, not occupied within (1) one hour of the published opening hour of the event, will become re-assignable by event organizers, with no refunds or rebates paid to vendor which originally contracted that space.
6. Vendor spaces are for the use of the registered vendor only. Vendor agrees not to sublet or apportion space to anyone, nor to promote the interest of any other non-approved vendor in any form without prior approval.
7. Vendor must notify event organizers immediately of cancellation. No refunds will be granted within (30) thirty days of the event.
8. EZOMB, LLC reserves the right to waive certain terms for any vendor at its discretion.
9. EZOMB, LLC also reserves the right to wait-list or reject any application for any reason.

## **VENDOR BOOTH SETUP AND SALES**

10. The vendor shall have an authorized adult (aged 18+) representative present throughout the event period and during the installation and dismantling of their vendor booth.
11. Security will not be provided before, during, or after the event. EZOMB, LLC will not be responsible for any losses or damages that may occur.
12. Vendors are responsible for collecting all applicable Sales Tax on sales made during the event, and must comply with all federal, state, and local business licensing and insurance requirements.
13. All displays and merchandise must be contained within your 10' X 10' space. Items should not extend beyond your booth space. Vendor shall not obstruct the view, or detract from adjoining vendors, nor be operated in any manner objectionable to others. Sidewalks and park walkways must remain open and clean at all times.
14. No hateful, discriminatory, flammable, or potentially harmful items may be displayed.
15. The sale and consumption of alcohol, drug, and tobacco products is strictly prohibited within park limits.
16. Event organizers and staff reserve the right to relocate vendors on event day as necessary.
17. Vendors are responsible for removing all trash from their booth area by the end of the event (8pm).

## **LIABILITY**

18. Vendor agrees to forever hold harmless EZOMB, LLC, all presenting sponsors, event organizers, staff, the Parks Dept. and City of Eureka Springs, and any and all volunteers from any claims or charges imposed for violation of any law or ordinance whether occasioned by the negligence of the vendor, or those holding under or through the vendor, and vendor shall indemnify and hold them harmless, against any and all loss, costs, damage, liabilities, causes of action, debts or expenses arising from or by reason of any injury to vendors, their employees, agents or guests or property from any cause whatsoever prior, during or subsequent to the period covered by the contract. When acts of God, work stoppages or any other cause not within the control of EZOMB, LLC make it impossible for vendor or any of their materials to occupy or function in the event area, the vendor shall waive any claim for damages or compensation. In addition, vendor further acknowledges that insurance covering the vendor and his/her property against damage, property and business interruption losses are the sole responsibility of the vendor.
